PROVIDER ACCESS POLICY

Introduction



This policy statement sets out The Friary's arrangements for managing the access of providers to Students at the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997.

Student Entitlement

All students in Years 8-13 are entitled:

- To find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point;
- To hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships through Pathways events, Partnership Evenings, assemblies, group discussions, taster events, etc.
- To understand how to make applications for the full range of academic and technical courses.

Provider Access Legislation (PAL)

This legislation specific that:

- Students during the 'First Key Phase' (Years 8 or 9) should have a mandatory two encounters.
- Students during the 'Second Key Phase' (Year 10 or 11) should have a mandatory two encounters.
- Students during the 'Third Key pPhase' (Year 12 or 13) should have a mandatory two encounters
 provided by the school although they are optional for students to attend.

This legislation is a key mechanism to further help learners understand and take-up, not just apprenticeships, but wider technical education options such as T-Levels and Higher Technical Qualifications.

These provider encounters will be scheduled during the main school hours and the provider will be given a reasonable amount of time to, as a minimum:

- Share information about both the provider and the approved technical education qualification and apprenticeships that the provider offers.
- Explain what career routes those options could lead to.
- Provide insights into what it might be like to learn or train with that provider (including the opportunity to meet staff and students from the provider).
- Answer questions from students.
